## Investment Objective

The objective of the portfolio is to achieve capital preservation over the long term combined with a higher level of income, while minimising volatility of investment returns in the short term.

## Investment Policy

The Oakhaven Core Income FR Fund's investment objective is to achieve capital preservation over the long term combined with a high level of income, while minimising volatility of investment returns in the short term. The investment process is based on macro-economic research to identify opportunities and monetize them in the most efficient way possible from a risk management perspective. The portfolio will invest in the South African market. Investments to be included in the portfolio will apart from assets in liquid form, include government bonds, money market instruments, and interest rate derivatives, as defined in Board Notice 90 of 2014. The instruments included in the portfolio will not exceed the weighted average duration limit of 2 years.

The Oakhaven Core Income FR Fund will seek to outperform its benchmark, being the STeFI Total Return Index and also to achieve this outperformance with less volatility through the market cycle.

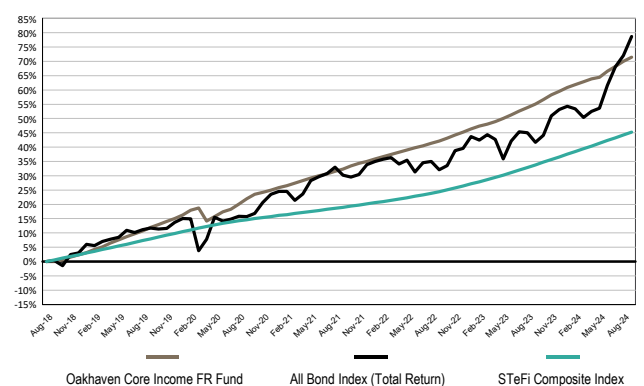

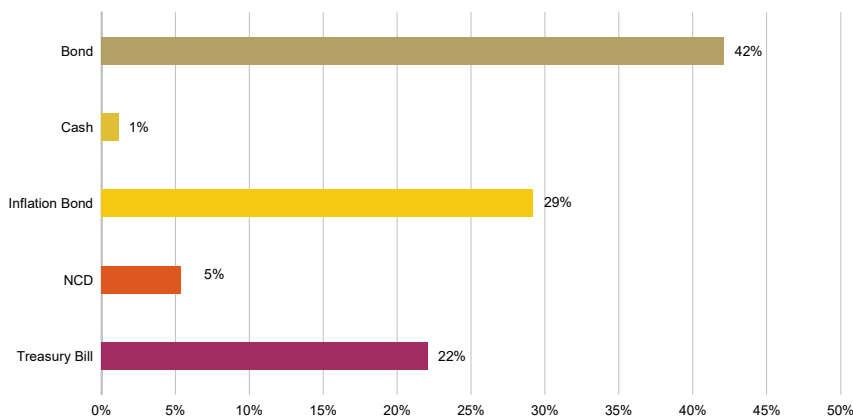

### Market Commentary

After keeping policy rates at 15-year highs since mid-2023, the SARB's MPC unanimously decided to cut the repo rate by 25bp to 8.0% at the September meeting. The MPC policy statement and the updated QPM projections suggested that the SARB's cutting cycle was likely to be gradual over the coming quarters, which collectively ensured that inflation expectations continued to moderate in the wake of the meeting. Indeed, the nominal yield curve continued to flatten and breakeven yields narrowed even further due to the SARB's vigilant messaging and firmer exchange rate backdrop. From an interest rate differential perspective, rand bulls also took encouragement from expectations that the SARB's cutting cycle was unlikely to be as deep as that of the Fed. Consequently, nominals generated a return of 3.8% on the month, while linkers only managed to post a return of 0.7%. Nominals, which are now up 15.6% for the year, have consistently outperformed linkers (y-t-d: 6.7%) since April as inflationary pressures have eased.

<b>Annualised Return:</b>	Is the weighted average compound growth rate over the performance period measured.
<b>Highest &amp; Lowest Return:</b>	The highest and lowest rolling twelve-month performance of the portfolio since inception.
<b>Total Expense Ratio (TER):</b>	Reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio.
