The charges outlined above represent the fees charged within the ETFs (external management fees) and have been estimated based on information in the ETFs' disclosure documents. Note that the fees within the ETFs are not tax deductible. Investors are charged each time they buy (entry fee) or sell (exit fee) units in the fund. These fees are charged to cover the costs of the underlying brokerage, foreign currency exchange, transaction fees and investment management service fees associated with investing in the underlying investments. Current entry and exit fees are 0.50%.

Small differences in fees and charges can have a big impact on your investment over the long term.

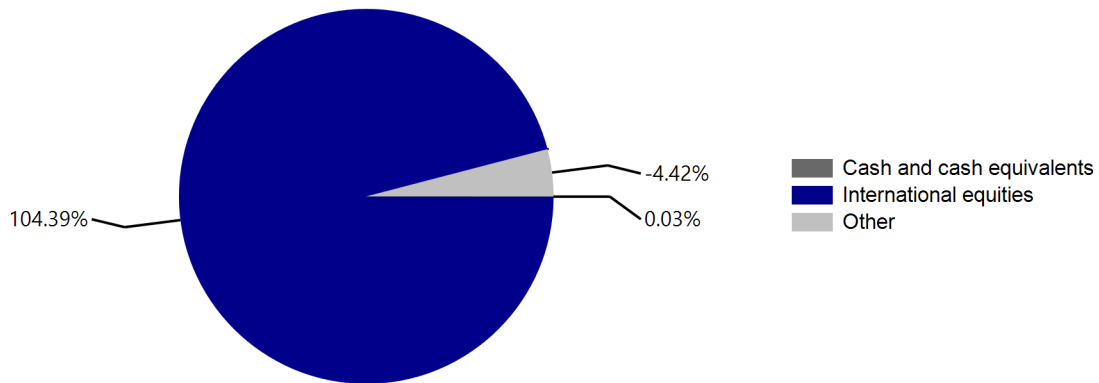
Anthony had \$10,000 in the fund when the fund received its first contribution, 05 February 2024 and did not make any further contributions. At the end of the period to 31 December 2024, Anthony received a return after fund charges were deducted of \$1,636 (that is 16.36% of his initial \$10,000). This gives Anthony a return after tax of \$1,533 for the period.

This shows the types of assets that the fund invests in.

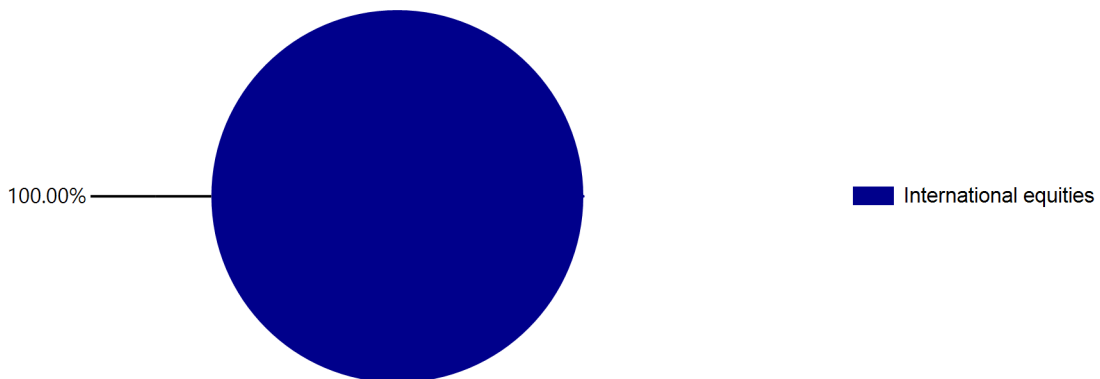
Actual Investment Mix

Notes

1. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. Market index returns have been used until 29 February 2024 and fund returns thereafter. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility.
2. As the fund only started accepting contributions on 5 February 2024, historical fee information is not available.
