This is a replacement fund update. It replaces the previous fund updates for the quarter ending 30 June 2024, first made publicly available on 8 August 2024 and 26 July 2024. This replacement fund update has corrected the past year's market index annual return figure in the "How has the fund performed?" section and returns figures used in the "Example of how this applies to an investor" section. The previous replacement fund update amended the actual investment mix percentages to only reflect the fund's assets in the "What does the fund invest in?" section of this fund update.

What is the purpose of this update?

This document tells you how the Schroder Sustainable Global Core PIE Fund (Hedged) has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: To outperform relative to the MSCI World ex Tobacco Index (net dividends reinvested) (Hedged) after fees with low index-relative risk across a broad range of market environments.

Strategy: The fund aims to provide exposure to global listed equities and is an actively managed strategy designed to target outperformance relative to the benchmark index with limited risk relative to the index. This strategy provides the benefits of index-based investing from a risk and cost perspective with the advantage of relative performance upside potential.


Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund when the fund received its first contribution, 01 December 2023 and did not make any further contributions. At the end of the period to 30 June 2024, Anthony received a return after fund charges were deducted of \$2,013 (that is 20.13% of his initial \$10,000). This gives Anthony a return after tax of \$1,907 for the period.




What does the fund invest in?

Notes

- A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. Market index returns have been used until 30 November 2023 and fund returns thereafter. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility.
- 2. As the fund only started accepting contributions on 1 December 2023, historical fee information is not available.
- 3. As the fund has not existed for a full year, figures in this example are based on returns from the date of the first fund contribution (1 December 2023).
