#### What is the purpose of this update?

This document tells you how the Aurora Growth Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

## Description of this fund

Objective: The investment objective of the fund is to deliver returns exceeding the CPI by 4.0% per annum before fees and tax, over the medium to long term.

Strategy: The fund is a diversified fund aiming to provide stable investment return through exposure to mostly income assets. The underlying portfolio is actively managed and includes cash, fixed interest, property, Australasian equities and international equities.




#### Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony incurred a loss after fund charges were deducted of \$585 (that is -5.85% of his initial \$10,000). This gives Anthony a total loss after tax of \$517 for the year.


# What does the fund invest in?

#### Notes

- <sup>i.</sup> A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. The risk indicator may therefore provide a less reliable indicator of the fund's future volatility. Market index returns have been used until 30 August 2021 and fund returns thereafter.
- <sup>iii.</sup> The bar chart shows fund returns after deducting fees and tax. Tax is deduced at the highest Prescribed Investor Rate of 28%. However, the market index returns are shown before deducting fees and tax.
- <sup>iii.</sup> As the Aurora Growth Fund only started accepting contributions on 20 August 2021, historical fee information is not available. The fund charges represent our best estimates of the fees and expenses that will be charged to the fund. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
