



> A measure that determines how assets move in relation to each other. Correlation risk arises when the correlation between asset-classes change. Correlation risk also arises when the correlation within an asset-class changes. Examples of correlation within asset classes include equity pairs trading,

> fixed income curve trading and commodities pairs trading. Applies to investment in shares or derivatives based on shares. The market price of shares varies depending on supply and demand of the shares. Equity
