How has the fund performed?

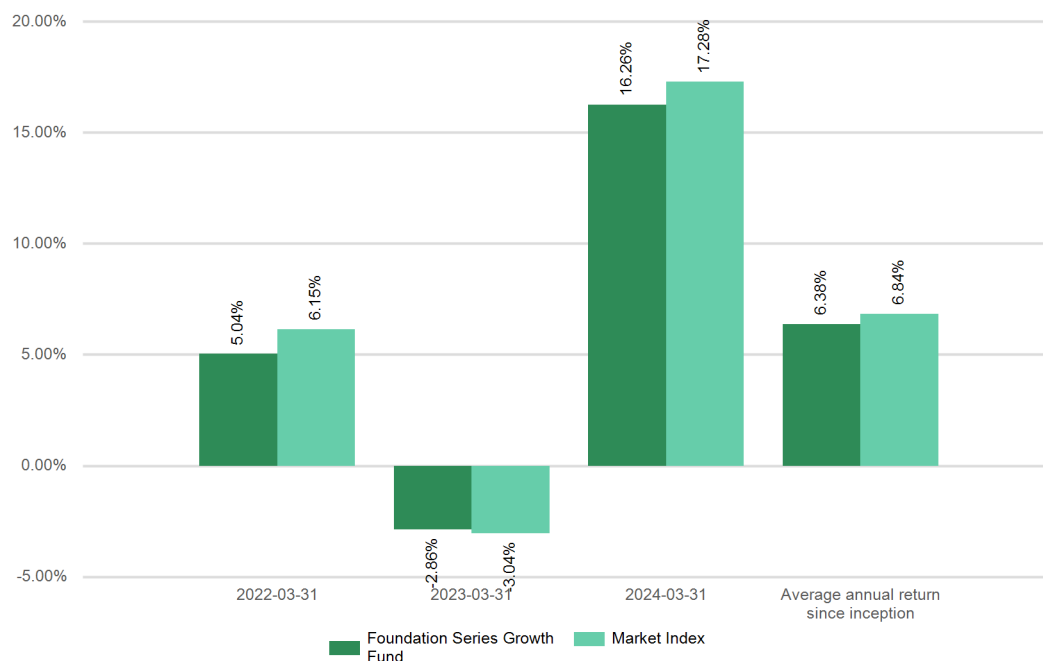

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

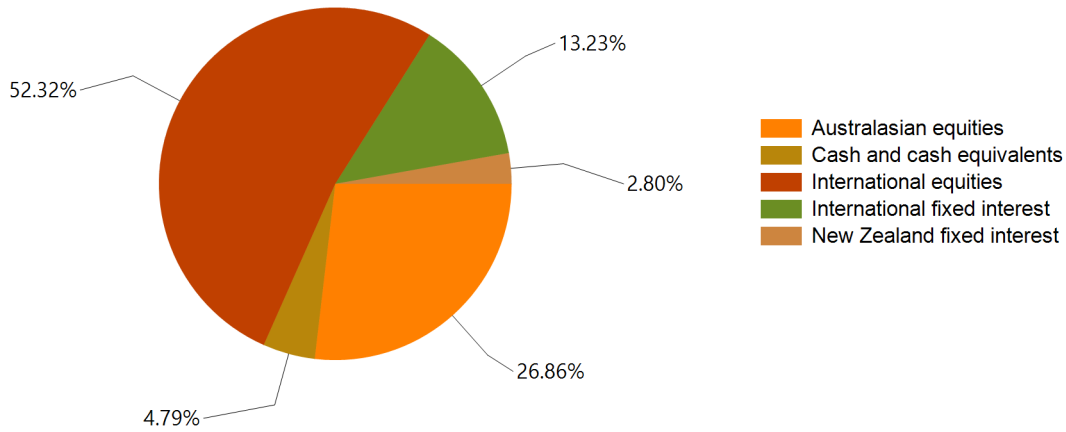
Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$1,243 (that is 12.43% of his initial \$10,000). This gives Anthony a return after tax of \$1,094 for the year.

This shows the types of assets that the fund invests in.

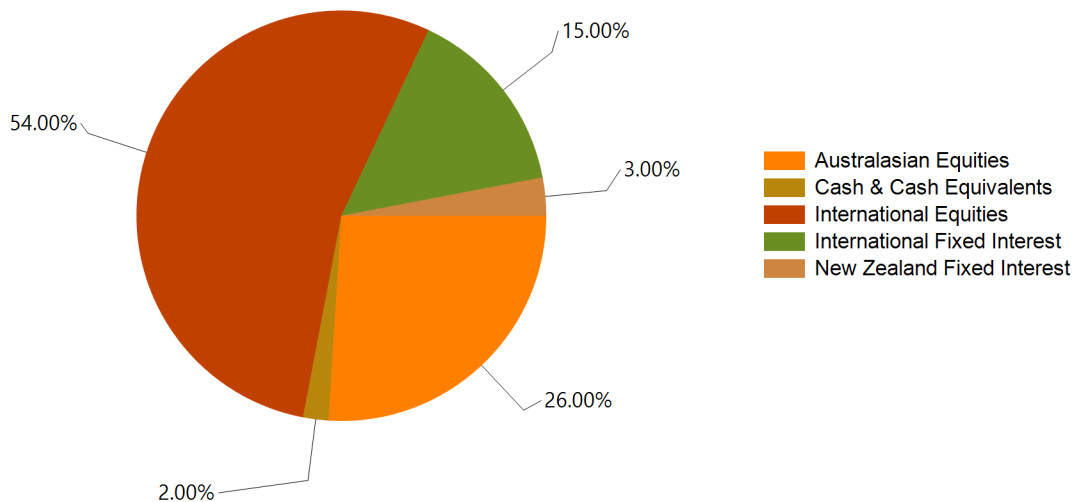
Actual Investment Mix

Notes

1. A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. 2. Underlying fund fees and expenses are reflected in the unit prices of the underlying funds that are used when calculating the unit price of the fund.
