What is the purpose of this update?

This document tells you how the Aurora Liquidity Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: To provide a gross return above the return of the Bloomberg NZBond Bank Bill Index on a rolling 12-month basis.

Strategy: Provides exposure to an actively managed portfolio of bank bills, floating rate notes and mainly shortterm deposits and securities, that targets capital security and liquidity. Environmental, Social and Governance characteristics are integrated into investment process where applicable.

Example of how this applies to an investor


Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$460 (that is 4.60% of his initial \$10,000). Anthony also paid \$36.00 in other charges. This gives Anthony a total return after tax of \$293 for the year.


What does the fund invest in?

Notes

- ^{i.} A combination of actual fund returns and market index returns have been used to determine the risk indicator as the fund has not been operating for the required five years. - ^{ii.} As the Aurora Liquidity Fund only started accepting contributions on 13 May 2022, historical fee information is not available. These have been estimated using information provided by the underlying fund manager and by reference to the underlying fund's disclosure documents.
