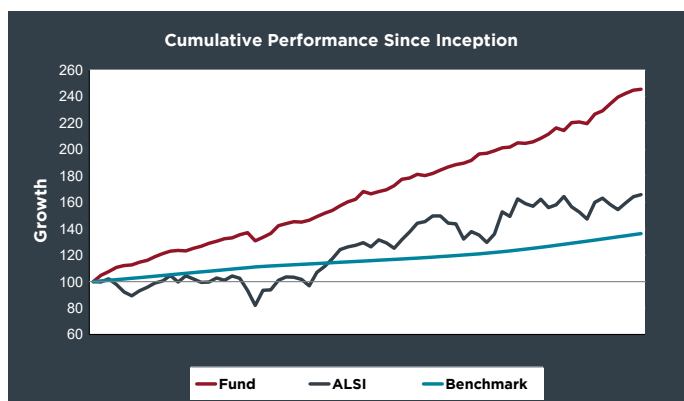

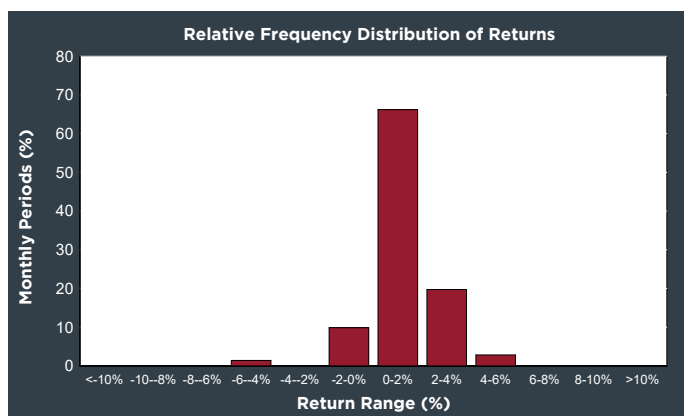

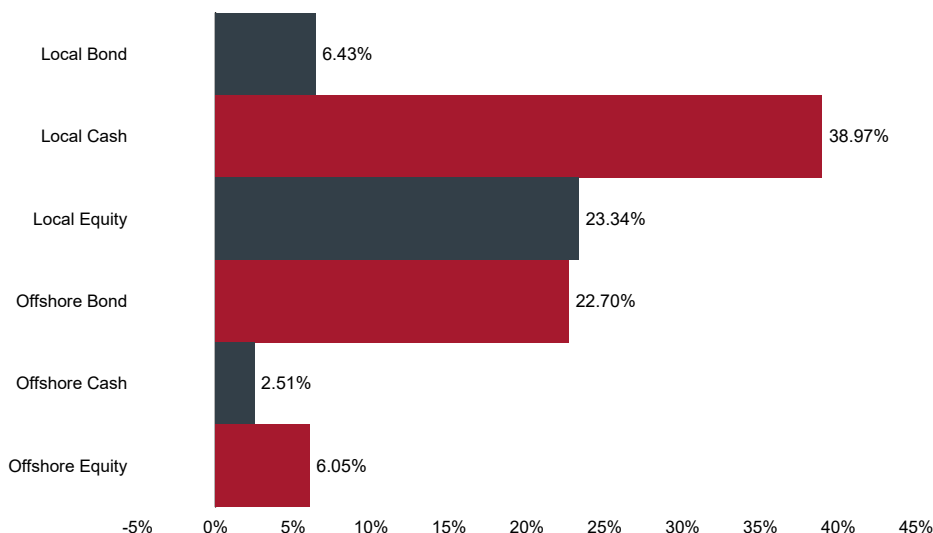

QUARTERLY PORTFOLIO & MARKET COMMENTARY BY THE INVESTMENT MANAGER

South African markets were weaker in the first quarter, following a strong finish to 2023. The FTSE/JSE All Share Index lost 2.2%. Bonds were negative and property was positive, outperforming the other asset classes for the quarter.

Global equity markets had a strong start to 2024 with broad-based gains. US markets were in the green with the S&P500 having its best start to a year since 2019. That market was supported by resilient economic data and better than expected corporate earnings. As expected, the US Federal Reserve (Fed) kept interest rates unchanged. However, Chairman Jerome Powell set a dovish tone at the March meeting, reiterating the forecast for three rate cuts later this year. The market had begun to doubt the number of rate cuts for this year as the last three readings of annualised US CPI came in above expectations. Powell addressed these higher readings and referred to them as a "bumpy ride" lower to target levels. Uncertainty remains regarding the timing of the first rate cut which the market initially expected to occur in March. Most major central banks kept interest rates unchanged this quarter and are likely to remain cautious as rate cuts begin in the second half of the year.

Outside of the US, performance was mostly positive. European equities rose along with the United Kingdom (albeit at a weaker pace). Asia was stronger as Japanese equities hit an over 30-year high, and Chinese equities rose from low levels. The United Kingdom entered a technical recession. The Euro zone narrowly avoided recession, with improving leading indicators showing that better growth lies ahead. China had some positive news in February. Strong travel data over the Lunar New Year was reported along with new stimulus measures announced by the Chinese government. These measures included curbs on short selling and a surprise 0.25% cut to the five-year loan prime rate.

The South African Reserve Bank, acting in line with major central banks, kept the local repo rate unchanged. The most important local event during the quarter was the Budget Speech delivered by Finance Minister, Enoch Godongwana. The speech did not have many surprises and was mostly focused on fiscal consolidation. Godongwana announced that the Government Finance Emergency Contingency Reserve Account (GFECRA) will be activated, with R150bn to be distributed to National Treasury. This amount will go towards reducing national debt servicing costs. This will support the fiscus in the short term, but reforms are required to stimulate sustainable real growth in the longer term.

The fund's performance was positive for the quarter. Trades in Grindrod, Impala Platinum and Anglo American contributed positively to performance, while trades in Zeda and Absa slightly detracted from performance.

FUND RISK

Leverage Risk: The Fund borrows additional funds, trades on margin or performs short sale trades to amplify investment decisions. This means that the volatility of a hedge fund portfolio can be many times that of the underlying investments due to leverage on a fund.

Derivative Risk: A Derivative positions are financial instruments that derive their value from an underlying asset. Derivatives are exposed to implicit leverage which could result in magnified gains and/or losses on the portfolio.

Counterparty Credit Risk: Counterparty risk is a type of credit risk and is the risk of default by the counterparty associated with trading derivative contracts. An example of counterparty credit risk is margin or collateral held with a prime broker.

Volatility Risk: Volatility refers to uncertainty and risk related to size of change of an instrument or portfolio. It is a statistical measure of the dispersion of returns for a given security or market index. Volatility is proportional to the directional exposure of a portfolio and is measured by Value at risk (VaR) which is a statistical technique used to measure and quantify the level of volatility.

Concentration and Sector Risk: A large proportion of total assets invested in specific assets, sectors or regions. Concentrated positions or concentrated sectors in a portfolio will material impact the returns of the portfolio more so than diversified portfolios.

Correlation Risk: A measure that determines how assets move in relation to each other. Correlation risk arises when the correlation between asset-classes change. Correlation risk also arises when the correlation within an asset-class changes. Examples of correlation within asset classes include equity pairs trading, fixed income curve trading and commodities pairs trading.

Equity Risk: Applies to investment in shares or derivatives based on shares. The market price of shares varies depending on supply and demand of the shares. Equity risk is the risk of loss due to the drop in the market price of shares. Equity risk can either be systematic risk which is risk to the entire market based on political and economic indicators or unsystematic risk which is company specific and includes risk relating to company profits, future prospects and general consensus on the company or sector.

GLOSSARY

Net Asset Value (NAV): means net asset value, which is the total market value of all assets in a portfolio including any income accruals and less and deductible expenses such as audit fees, brokerage and service fees.

Annualised Return: is the weighted average compound growth rate over the performance period measured.

Highest & Lowest Return: The highest and lowest rolling twelve-month performance of the portfolio since inception.

Total Expense Ratio (TER): reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's.

Transaction Costs (TC): is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns.

Total Investment Charge (TIC): should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager.

Total Investment Charges (TIC%): = TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).

Sharpe Ratio: The ratio of excess return over the risk-free rate divided by the total volatility of the portfolio.

Sortino Ratio: The ratio of excess return over the risk-free rate divided by the downside deviation of the portfolio.

Standard Deviation/Volatility: The deviation of the return of the portfolio relative to its average.

Derivative/Financial Instrument: A contract that derives its value (positive or negative) from another asset.

Drawdown: The greatest peak to trough loss until a new peak is reached.

Correlation: A number between -1 and 1 indicating the similarity of the dispersion of returns between the portfolio and another asset or index with 1 being highly correlated, -1 highly negatively correlated and 0 uncorrelated.

Value at Risk (VaR): Value at risk is the minimum loss percentage that can be expected over a specified time period at a predetermined confidence level.

Frequency Distribution: How often returns occur within a specified band.
