
# Fund Profile

The Protea International Hedge Fund SICAV plc ("Fund") is organised under the laws of Malta as a multi class public limited liability company with variable share capital (SICAV) pursuant to the Companies Act (Chapter 386 of the Laws of Malta). The Fund is licensed by the Malta Financial Services Authority ("MFSA") to carry out the activities of a collective investment scheme in the form of a professional investor fund targeting qualifying investors, with registration number SV576 and registered address at 36, Manoel de Vilhena Street, Gzira GZR1012, Malta. The Fund is approved by the Financial Sector Conduct Authority ("FSCA") in South Africa under Section 65 of the Collective Investment Scheme Control Act 2002 and has been categorised as a Collective Investment Scheme for public sale in South Africa. The investment manager systematically identifies individual mispriced securities whilst ensuring sufficient diversification to guard against inappropriate risk concentration. The fund focuses on developed market listed equities worldwide without any limitation to equities of a particular market sector, region, industry of market capitalization, with a maximum gross exposure limit of 400% (i.e. maximum 4x leverage).

# **Investment Strategy**

The portfolio is managed as a long/short hedge fund. Its core strategy is to be long undervalued equities and short overvalued equities whilst ensuring that there is sufficient diversification to guard against inappropriate risk concentration. The equities are selected by following a "quantamental" investment approach, which combines traditional fundamental analysis with quantitative investment techniques.




# Portfolio Objective

### Market Commentary

The respective August returns for the three Non-Institutional share classes of the fund were +4.3% in US Dollars (USD), +2.0% in Euros (EUR), and +2.0% in British Pounds (GBP). The MSCI World Index returned +2.6% in USD, +0.4% in EUR, and +0.4% in GBP for the month. In terms of our sub-strategies, Longs contributed 4.1%, while Shorts contributed 0.2%. Special Situations and Futures & Options made no contribution for the month, while Currency translation accounted for the balance of the impact on the fund's reported returns.

Longs listed in the USA, Great Britain, the Eurozone, Switzerland, Norway, Sweden, Singapore, Hong Kong, and in Australia contributed positively for the month. Longs listed in Canada, Denmark, and in Japan detracted from August's performance. Our top Longs for the month were an emerging market banking group, a social media platform company, and a online travel platform company. Our worst-performing Longs were a Chinese ecommerce business, a Canadian convenience retailer, and a

Shorts listed in the USA contributed positively for the month. Shorts listed in Great Britain, the Eurozone, Switzerland, Denmark, Norway, and in Sweden detracted from the fund's August return. Our top Shorts were an emerging market ecommerce business (which dropped by more than 50% during the month), an electric vehicle manufacturer, and a medical implant manufacturer. Our worst-performing Shorts were an autonomous vehicle company, a biotechnology company, and a medical equipment manufacturer. It is pleasing that our Shorts contributed positively during a month in which equity indices generally rose.

We held no Special Situation or Future & Option positions in the fund during the past month. Currency translation detracted more than 2% from the returns reported in EUR and in GBP (the fund's functional currency is USD).

Protea Capital Management continues to apply our 'quantamental' process in order to grow the wealth of our investors. Thank you for joining us on this long-term iournev.

### **Fund Risk**

Leverage Risk: The Fund borrows additional funds, trades on margin or performs short sale trades to amplify investment decisions. This means that the volatility of a hedge fund portfolio can be many times that of the underlying investments due to leverage on a fund.

Derivative Risk: Derivative positions are financial instruments that derive their value from an underlying asset. Derivatives are exposed to implicit leverage

which could result in magnified gains and/or losses on the portfolio.

Counterparty Credit

Counterparty risk is a type of credit risk and is the risk of default by the counterparty associated with trading derivative contracts. An example of counterparty credit risk is margin or collateral held with a prime broker.

Volatility Risk: Volatility refers to uncertainty and risk related to size of change of an instrument or portfolio. It is a statistical measure of the dispersion of

returns for a given security or market index. Volatility is proportional to the directional exposure of a portfolio and is measured by Value at risk (VaR) which is a statistical technique used to measure and quantify the level of volatility.

Concentration and Sector Risk:

A large proportion of total assets invested in specific assets, sectors or regions. Concentrated positions or concentrated sectors in a portfolio will material impact the returns of the portfolio more so than diversified portfolios.

Correlation Risk: A measure that determines how assets move in relation to each other. Correlation risk arises when the correlation between asset-classes change. Correlation risk also arises when the correlation within an asset-class changes. Examples of correlation within asset classes include

equity pairs trading, fixed income curve trading and commodities pairs trading

**Equity Risk:** The market price of shares varies depending on supply and demand of the shares. Equity risk is the risk of loss due to the drop in the market

price of shares.

Currency/Exchange Rate Risk:

Assets of a fund may be denominated in a currency other than the Base Currency of the fund and changes in the exchange rate between the Base Currency and the currency of the asset may lead to a depreciation of the value of the fund's assets as expressed in the Base
