
🗱 Fund Profile

The Protea International Hedge Fund SICAV plc ("Fund") is organised under the laws of Malta as a multi class public limited liability company with variable share capital (SICAV) pursuant to the Companies Act (Chapter 386 of the Laws of Malta). The Fund is licensed by the Malta Financial Services Authority ("MFSA") to carry out the activities of a collective investment scheme in the form of a professional investor fund targeting gualifying investors, with registration number SV576 and registered address at 36, Manoel de Vilhena Street, Gzira GZR1012, Malta. The Fund is approved by the Financial Sector Conduct Authority ("FSCA") in South Africa under Section 65 of the Collective Investment Scheme Control Act 2002 and has been categorised as a Collective Investment Scheme for public sale in South Africa. The investment manager systematically identifies individual mispriced securities whilst ensuring sufficient diversification to guard against inappropriate risk concentration. The fund focuses on developed market listed equities worldwide without any limitation to equities of a particular market sector, region, industry of market capitalization, with a maximum gross exposure limit of 400% (i.e. maximum 4x leverage).

Investment Strategy

The portfolio is managed as a long/short hedge fund. Its core strategy is to be long undervalued equities and short overvalued equities whilst ensuring that there is sufficient diversification to guard against inappropriate risk concentration. The equities are selected by following a "quantamental" investment approach, which combines traditional fundamental analysis with quantitative investment techniques.





🎇 Market Commentary

The respective December returns for the three Non-Institutional share classes of the fund were -4.2% in US Dollars (USD), -2.2% in Euros (EUR), and -2.6% in British Pounds (GBP). The MSCI World Index (the Index), on a total return basis, returned -2.6% in USD, -0.5% in EUR, and -1.0% in GBP for the month. For the year, the fund returned +2.1% in USD, +9.1% in EUR, and +4.1% in GBP.

The fund's return for 2024 is substantially below the Index's 19.2% return for the year (in USD), with most of the difference occurring in the fourth quarter. While the Index is not the fund's benchmark (the fund's individual holdings and average long and short exposures are materially different from that of the Index), we quote the Index's return due to our aspiration of wanting to outperform a relevant long-only index over the long-term, while limiting deep drawdowns. We haven't achieved this in the first three years of the fund's existence, but we know from previous experience that this endeavour requires patience, and that relative returns can change quickly.

The question also arises whether the MSCI World is a relevant comparison. Of the Index's +19.2% return, +17.5% was from the US Market (USD shares). All other markets therefore contributed only +1.7% to the Index's 2024 return. USD shares returned 25% for 2024 and represented an average weight of 72% in the Index over the course of 2024. Outside of the US, Europe returned a paltry +3.3%, Japan and the UK less than +9% each, and six markets delivered negative returns. The fund's average exposure to USD shares over the course of 2024 was 29%, 17% to Hong Kong shares, 15% to European shares, 10% to UK shares, and low single digits to a handful of other markets. Furthermore, the largest USD shares performed way above average. The 'Magnificent 7' plus Broadcom contributed +9.4% to the Index (i.e. almost half of the Index's return. The bottom line is that our lack of significant exposure to the largest USD shares in 2024 cost us in relative performance terms.

In terms of sub-strategy attribution for the year, Longs contributed 12%, while Shorts detracted 3%. Special Situations and Futures & Options made no contribution for the year. The difference between the total of the sub-strategy returns and the overall fund return is due to net funding costs and expenses incurred within the fund. These will become less of a drag as the fund size grows.

We are optimistic about the future prospects of the fund and appreciate your support.

Note that, going forward, we will make reference to the FTSE Developed World Index rather than to the MSCI World Index. These two indices are almost identical, but MSCI might request licencing fees for the continued use of their indices.

🗱 Fund Risk

Leverage Risk:	The Fund borrows additional funds, trades on margin or performs short sale trades to amplify investment decisions. This means that the volatility of a hedge fund portfolio can be many times that of the underlying investments due to leverage on a fund.
Derivative Risk:	Derivative positions are financial instruments that derive their value from an underlying asset. Derivatives are exposed to implicit leverage which could result in magnified gains and/or losses on the portfolio.
Counterparty Credit Risk	Counterparty risk is a type of credit risk and is the risk of default by the counterparty associated with trading derivative contracts. An example of counterparty credit risk is margin or collateral held with a prime broker.
Volatility Risk:	Volatility refers to uncertainty and risk related to size of change of an instrument or portfolio. It is a statistical measure of the dispersion of returns for a given security or market index. Highest & Lowest Return:	The highest and lowest rolling twelve-month performance of the portfolio since inception.
Total Expense Ratio (TER):	Reflects the percentage of the average Net Asset Value (NAV) of the portfolio that was incurred as charges, levies and fees related to the management of the portfolio. A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER cannot be regarded as an indication of future TER's.
Transaction Costs (TC):	Is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns.
Total Investment Charge (TIC):	Should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager.
Total Investment Charges (TIC%):	= TER (%) + TC (%): The Total Investment Charges (TIC), the TER + the TC, is the percentage of the net asset value of the class of the Financial Product incurred as costs relating to the investment of the Financial Product. It should be noted that a TIC is the sum of two calculated ratios (TER+TC).
Leverage/Gearing:	The use of securities, including derivative instruments, short positions or borrowed capital to increase the exposure beyond the capital employed to an investment.
Alpha:	Denoted the outperformance of the fund over the benchmark.
Sharpe Ratio:	The ratio of excess return over the risk-free rate divided by the total volatility of the portfolio.
Sortino Ratio:	The ratio of excess return over the risk-free rate divided by the downside deviation of the portfolio.
Standard Deviation:	The deviation of the return of the portfolio relative to its average.
Drawdown:	The greatest peak to trough loss until a new peak is reached.
Correlation	A number between -1 and 1 indicating the similarity of the dispersion of returns between the portfolio and another asset or index with 1 being highly correlated, -1 highly negatively correlated and 0 uncorrelated.
Value at Risk (VaR):	Value at risk is the minimum loss percentage that can be expected over a specified time period at a predetermined confidence level.
