What is the purpose of this update?

This document tells you how the Stewart Investors Worldwide Leaders Sustainability Fund has performed and what fees were charged. The document will help you to compare the fund with other funds. FundRock NZ Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Objective: To achieve long-term capital appreciation by investing in companies which contribute to, and benefit from, sustainable development. The fund invests in larger capitalisation companies with a minimum investible market cap (free float) of US\$5 billion at the time of initial investment. The fund aims to exceed the MSCI All Country World Index (NZD) over rolling five-year periods before fees and taxes. The fund is actively managed, and the benchmark is not used to limit or constrain how the fund's portfolio is constructed.

Strategy: Aims to achieve its investment objective by investing in a diversified portfolio of equity or equity-related securities of larger capitalisation companies which are listed in, traded, or dealt on any of the regulated markets worldwide. The fund does not hedge currency risk.


The market index return is MSCI All Country World Index (NZD). This has been the market index since the inception of the fund.

Example of how this applies to an investor

Small differences in fees and charges can have a big impact on your investment over the long term.

Anthony had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Anthony received a return after fund charges were deducted of \$1,352 (that is 13.52% of his initial \$10,000). This gives Anthony a return after tax of \$1,234 for the year.




This shows the types of assets that the fund invests in.
