Investment Objective and Strategy

The fund will have maximum flexibility to invest in a wide range of investments including, but not limited to, listed and unlisted equities, scrip loans, options, warrants, convertible debt securities, preference shares, futures, ETFs and derivatives. The fund's investment strategies will be focused on South African markets but may be supplemented by foreign investments. Benchmark is a composite of 50% JSE All Share Index and 50% Short-Term Fixed Interest Composite Index.

Investor

The Fund is appropriate for investors who aim to maximise capital accumulation over a medium term time horizon and whom understand the risks and exposures of a hedge fund. The investor must be willing to tolerate a higher volatility of returns. The Fund is not compliant with Regulation 28 of the Pension Funds Act.

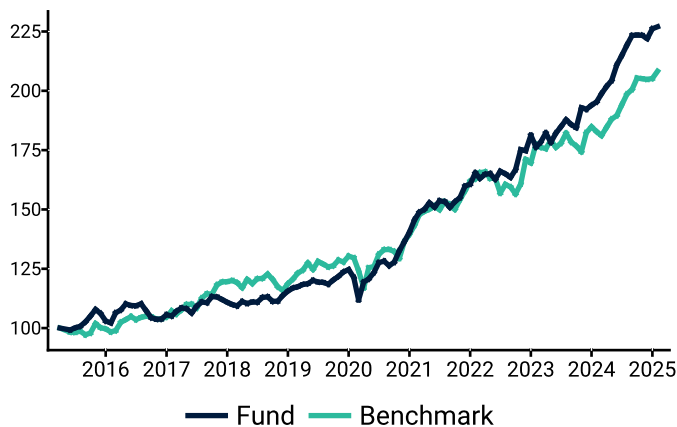

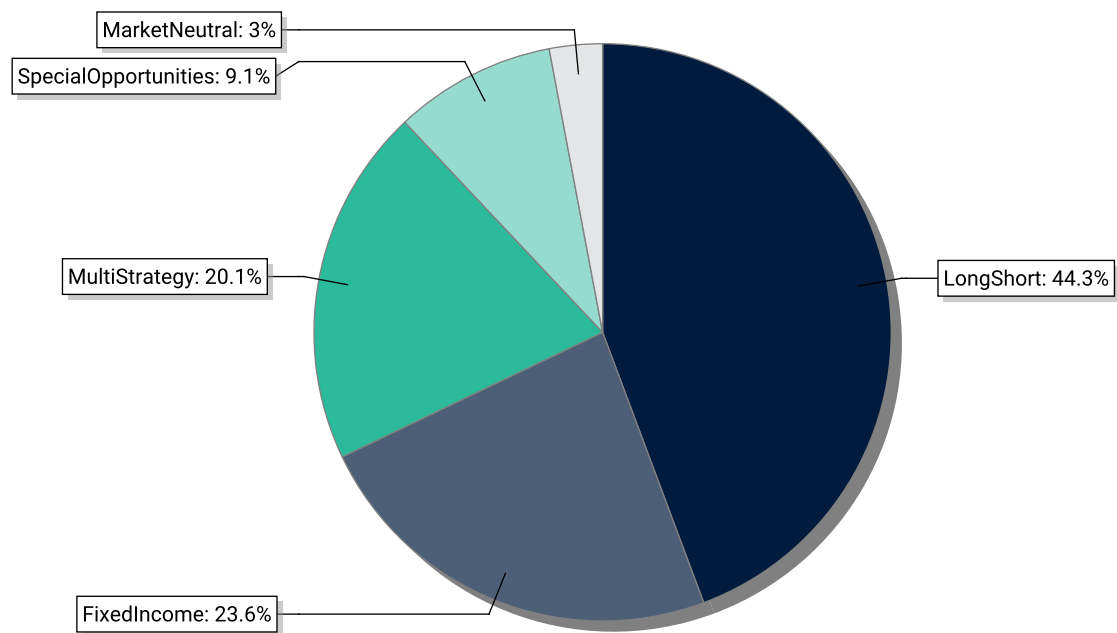

GLOSSARY

Net Asset Value: the total market value of all assets in a portfolio including any income accruals and less and deductible expenses such as audit fees, brokerage and service fees. **Annualised Return:** The weighted average compound growth rate over the performance period measured. **Highest and Lowest Return:** The highest and lowest rolling 12 month performance of the portfolio since inception.

TOTAL EXPENSE RATIO

A higher TER does not necessarily imply a poor return, nor does a low TER imply a good return. The current TER may not necessarily be an accurate indication of future TER's. Transaction Costs are a necessary cost in administering the financial product and impacts financial product returns. The TER and transaction cost calculations are based on a 1 year rolling period. Fee calculations are based upon their most recent published figures, being the date of this report.
